Key indicator 1: Sports Coach to offer lunchtime activities in Zoned areas so children can try a range of sports. Equipment for play leader lunchtimes purchased to ensure that Play Leaders have equipment to support their role Uniform for Play Leaders purchased so that play leaders stand out on the playground	The zoned areas for the specific games have worked well, they are staff led and offer children the chance to try a range of sports and can change dependent on pupil interests. Children report to enjoying lunch more. The additional equipment is being used by the children and they are keen to join in with games. The Play Leaders stand out and pupils know they can go to them as they need.	Enjoyment of lunchtime has increased in the most recent survey, children reported feeling happier with the provision provided. The School leaders are encouraging children to play a range of games including cricket, archery and athletics.
Key indicator 2: Sports Coach led Sports Leader programme (10 lessons per year) Additional Swimming Lessons were delivered to ensure year 6 met the measure. Sports Coach worked towards the criteria for School Games Gold award – more school competitions in wider sports.	The play leaders were trained to run activities and were given clear roles at lunchtime. All children in year 6 who attended the swimming lessons made progress. The profile of PE was raised in the school and the school has participated in a range of external and internal events to keep the importance of PE high in the school	Play leaders were very successful and ran events each week following their training. There were some issues with regard to the weather that meant that some events were cancelled. We were able to rearrange most of them.
Key indicator 3: CPD accessed by Sport Coach and class teachers in specific areas of PE Sports Coach was able to deliver additional PE sessions to pupils. There were opportunities for other providers to take PE lessons this included dance specialist sessions	All Sports Coach teaching was of a high quality and was observed in lesson visits. Teachers were able to experience lessons with the coach to ensure that their knowledge and skills remained proficient. The Sports Coach has subject specific skills and has provided high quality PE sessions. High quality dance lessons delivered by specialists	All CPD was of a high standard, the year 1 class teacher attended dance sessions and led them with her class. All lesson visits showed a clear improvement of PE across the board. Dance specialist was able to lead dance and gymnastics for 4 year groups.













Key indicator 4: SEN Charnwood Offer taken up to offer sporting events for SEND pupils Subsidised Y6 residential trip to support OAA activities	There were a number of opportunities for SEND children to access the local Charnwood partnership. The residential offered a range of activities beyond those found in the local environment: climbing, archery, raft work etc	Some of the Charwood offer was delayed due to bad weather and access to sports facilities but they were rearranged. Residential was very successful and children were able to participate in all planned activities.
Key indicator 5: Access to the local PE network – fees paid	This was used to ensure that Woolden Hill was able to participate in local tournaments and inter-school competitions	A number of events attended including tennis, basketball and SEND events. Many events locally meaning transport costs were reduced.
